Written Test: Eligible applicants must appear for a written test of 50 marks. The written test shall be of Madhyamik standard and the questions shall be MCQ type. English- 10 marks, Arithmetic-10 marks, General Knowledge- 10 marks, Computer Knowledge- 20 marks.

Candidates shall be shortlisted on the basis of merit of marks obtained in the written test and shall be called for a Computer Practical test and Personality Test.

Computer Practical Test: The candidates shortlisted after the written test shall then appear for a computer practical test of 40 marks.

Personality Test: The computer practical test shall be followed by a personality test of 10 marks. Final panel shall be made on the basis of marks obtained by the candidates in the Written test, Computer Practical test and Personality Test.
